Ways to Give

Options you might consider:

Bequest: It is easy to make a gift through your will or trust. This can be a fixed dollar amount, a specific asset, or a percentage of your estate.

Retirement Account: A bequest from a retirement account supports the church and may lessen the tax burden on your heirs.

Charitable Trust: These trusts offer benefits during your lifetime and eventual income to the church and other beneficiaries.

Other: Many other giving opportunities might prove ideal for your situation.

Estate and asset planning often requires help.

To ensure that a particular legacy gift is right for you, consult with your legal and financial advisors.
